1. Identity of person responsible for the data

HIPOGES IBERIAL, S.L with its registered office at C/Albacete nº3, 5ª floor (28027) Madrid, and with Corporate Tax Identification number B85610228 ("**HIPOGES**"), is the owner and administrator of the domain name <u>www.hipoges.com</u> (the "**Website**").

2. User acceptance and identification

By accessing and browsing this Website, the User acknowledges that they have read and understood this Legal Notice and the Terms of Use as well as our Privacy and Cookies Policy and expressly consents to its application when browsing this Website.

Through its Website, HIPOGES can offer services, subject to contractual conditions of which the User Will be informed in each specific case.

The User must always identify themselves with their personal email address.

The User guarantees HIPOGES and third parties the quality of the information provided, that is to say, that the data and information provided is real, accurate, up-to-date and also belongs to the User and not to any third parties. The User shall be responsible for the truthfulness of the personal data provided and shall hold HIPOGES harmless against claims by third parties, or with regard to fines or compensation for damages thar they could suffer in the event of a breach.
